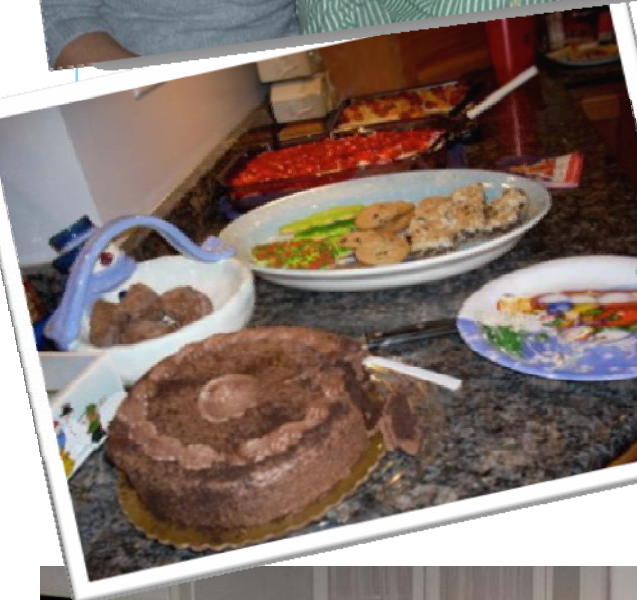

Trains the Trainers



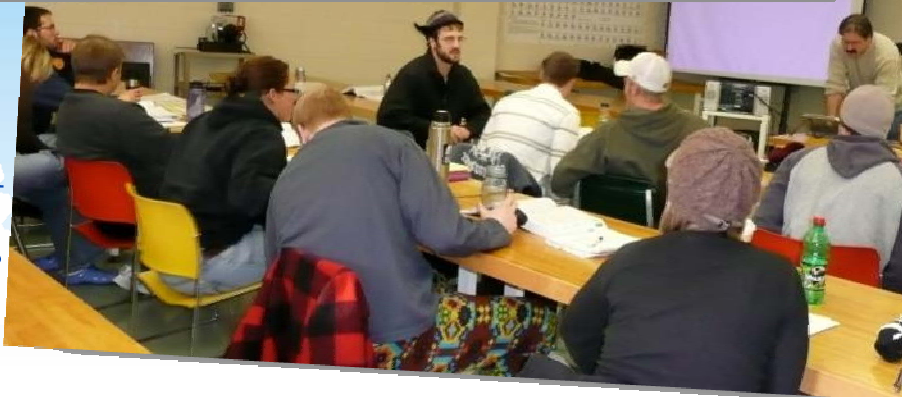
